This letter contains important information regarding your DNR permit application to Pier in Walworth County. Your application has reached its date of closure and is considered complete. Wisconsin law (chapters 30 and 281, Wisconsin Statutes) requires that the public be allowed an opportunity to comment on projects like yours. The next step in the individual permit review process is a Notice of Pending Application and public comment period.

The enclosed document is a "Notice of Pending Application" for your project. The Department will publish the notice on our Internet website. The 30-day period to submit written public comment and the 20-day period to request a public hearing in writing will begin on the date on which the Department first publishes the notice on our Internet website. If a public hearing is held, the period to submit written public comment will end 10 days after the date the hearing is completed.

Notice of Pending Application for Proposed Pier

Thomas Tully, 33 North Dearborn Street, Suite 2450, Chicago, IL 60602 has applied to the Department of Natural Resources for a permit to Pier. The project is located in the NE of SE 1/4 of Section 10 in Township 01N, Range 17E located in Town of LINN, Walworth County.

The proposed project includes the construction of a new 130' long x 8' wide pier. The trident-style structure is designed for two 13'W x 33'L boat slips and a 11'W x 10'L platform, supported on eight new rock-filled cribs.

The Department will review the proposal provided by the applicant and any information from public comments and the public informational hearing. The Department will determine whether the proposal complies with ss. 1.11, 30.12 and 30.208, Stats., and ch. NR 150, Wis. Adm. Code, and ensure that the required mitigation meets the standards in s. 281.36(3r), Stats. if the project impacts wetlands.

The Department has made a tentative determination that it will issue the permit for the proposed activity.

If no hearing is requested, the Department may issue its decision without a hearing. If a public informational hearing is held, comments must be postmarked no later than 10 days following the date on which the hearing is completed.

The final decision may be appealed as indicated in the decision document.
