IP-SE-2021-65-00235**

PERMIT AMENDMENT

Kimberly McCarter, N 1611 Shadow Lane, Linn, WI 53147 is hereby granted under Section 30.20(2) and 30.208 Wisconsin Statutes, an amendment to permit number IP-SE-2021-65-00235, which authorized the permittee to dredging located in the NE 1/4, NW 1/4, Sec. 18, T. 01N, R. 17E, Town of LINN, Walworth County. This is an approved amendment to place the dredged materials into a new/approved location. The applicant is bound by the conditions of the original permit and by any conditions of this amendment.

AMENDED PERMIT CONDITIONS

1. All original permit conditions remain in effect, except where modified by the amended permit conditions below.
2. You must place all removed materials in the location shown on the approved plans submitted 1/22/2021. The location approved, Reesman – Whelan Aggregate Site (N2376 State Hwy 14, Delavan, WI, 53115), must ensure no materials enter any nearby navigable waterway or wetland.

FINDINGS OF FACT

1. Kimberly McCarter filed a request with the Department on 01/22/2021, for an amendment to Dredging located in the NE 1/4, NW 1/4, Sec. 18, T. 01, R. 17E, Town of LINN, Walworth County under Section 30.20(2) and 30.208 Wisconsin Statutes.
2. Kimberly McCarter was granted Permit Number IP-SE-2021-65-00235 to dredge 321 cubic yards of lakebed and built-up sediment from the bed of Geneva Lake.
3. On behalf of permit applicant Kimberly McCarter, John Paterson with Integrated Lakes Management filed a request to amend the original permit on 06/04/2021 to change the final location of the dredged materials.
4. The Department has determined that the proposed amendment to the permit will not affect the Findings of Fact and Conclusions of Law of the original permit. A copy of the original permit is attached to this amendment.

CONCLUSIONS OF LAW

1. The Department has authority under Section 30.20, Wisconsin Statutes, and the foregoing Findings of Fact, to issue an order granting the permit amendment requested.
2. The Department has complied with Section 1.11, Wisconsin Statutes and NR 150, Wisconsin Administrative Code.
