

Notice of Public Hearing for Proposed Pier

Chris Hummel, N1958 Cty RD O, Delavan, WI 53115 has applied to the Department of Natural Resources for a permit to place a pier/wharf on the bed of Geneva Lake.

The project is located in the NW1/4 of the SE1/4 of Section 06, Township 01 North, Range 17 East, Village of Williams Bay, Walworth County.

The proposed project is to place a pier at 140 Birch Walnut Williams Bay WI 53191 with 9 rock filled wood cribs on the lake bed of Geneva lake with a total surface area of 817 square feet. All materials will be brought in by barge and any materials such as old cribs will be removed up land. The main pier is 8' wide and 100' long with a 10' wide and 20' long load platform incorporated into the end of the pier. The pier has 1 canopy structure (not including side curtains) with 6' wide 30' long slip fingers connected with 8' wide 17' long crosswalks. The total pier width is 37 feet.

The Department will review the proposal provided by the applicant and any information from public comments and the public informational hearing. The Department will determine whether the proposal complies with ss. 1.11 and 30.12(3m), Stats., and ch. NR 150, Wis. Adm. Code, and ensure that the required mitigation meets the standards in s. 281.36(3r), Stats. if the project impacts wetlands.

The Department has made a tentative determination that it will issue the permit or contract for the proposed activity.

The public hearing is scheduled for Thursday, February 6, 2020 at 3:00 p.m. located at the Village of Williams Bay, 250 Williams Street, Council Room.



Comments should include the docket number or applicant name, and should relate to whether the project meets the legal standards listed above. Comments must be postmarked no later than 10 days after the date that the public informational hearing is completed in order for them to be considered.

The final decision may be appealed as indicated in the permit decision document.
