The 30-day period to submit written public comment and the 20-day period to request a public hearing in writing will begin on the date on which the Department first publishes the notice on our Internet website. Notice of Pending Application for Proposed Pier

Thomas Stuhley, 2110 Casey Key Road, Nokomis, FL 34275-3380 has applied to the Department of Natural Resources for a permit to make changes to a Pier. The project is located in the SW of SE 1/4 of Section 06 in Township 01N, Range 17E located in Village of WILLIAMS BAY, Walworth County.

Proposed project includes the addition of one boat slip to the existing pier structure. The 13' wide boat slip would be framed with a 4' L-shaped leg. New overall width of the proposed pier structure is 39'.

The Department will determine whether the proposal complies with ss. 1.11, 30.12, and 30.208, Stats., and ch. NR 150, Wis. Adm. The Department has made a tentative determination that it will issue the permit for the proposed activity.

If no hearing is requested, the Department may issue its decision without a hearing. If a public informational hearing is held, comments must be postmarked no later than 10 days following the date on which the hearing is completed.

The final decision may be appealed as indicated in the decision document.
