This letter contains important information regarding your DNR permit application to Dredging in Walworth County. Your application has reached its date of closure and is considered complete. Wisconsin law (chapters 30 and 281, Wisconsin Statutes) requires that the public be allowed an opportunity to comment on projects like yours. The next step in the individual permit review process is a Notice of Pending Application (NoPA) letter and public comment period. In addition, a public informational hearing has been requested.

The Department has scheduled a public informational hearing on your proposal for Monday, April 26, 2021 at 2:00pm.

The hearing provides an opportunity for you and the Department to gather additional facts to help gauge the possible environmental impacts of your proposed project. The hearing is informational only. Department staff will manage the hearing agenda according to set procedures to allow all who attend a chance to be heard and to gather as much factual information as possible.

The enclosed document is a "Notice of Pending Application/Notice of Public Hearing" for your project. The Department will publish the notice on our Internet website. The 30-day period to submit written public comment will begin on the date on which the Department first publishes the notice on our Internet website. The period to submit written public comment will end 10 days after the date the hearing is completed.

Before the Department can proceed further toward a decision, state law requires that you:

- 1. Publish this as a Class I Notice, at your expense, in the Lake Geneva Regional News, 315 Broad Street, PO Box 937, Lake Geneva, WI 531747-0937, phone (262) 248-4444, email: <a href="mailto:shinske@lakegenevanews.net">shinske@lakegenevanews.net</a>, at least 10 days prior to the hearing date (4/16/2021).
- 2. Provide the Department an Affidavit of Publication from the newspaper to prove that the notice was published.
- 3. Provide a copy of the enclosed notice to the parties listed below by U.S. Mail or in person. If provided by U.S. Mail, send the notice Certified Mail Return Receipt Requested. If provided in person, obtain a signature from each party to verify that they received the notice. You may notify others at your discretion. You also must provide a copy of the notice to any person or group who asks you to do so.

## Notice of Pending Application/Public Hearing for Proposed Dredging

Kimberly McCarter, N 1611 Shadow Lane, Linn, WI 53147, has applied to the Department of Natural Resources for a permit for Dredging. The project is located in the NWNE of Section 18, Township 01N, Range 17E, in the Town of LINN, Walworth County.

The project is located in the Town of LINN, Walworth County, on the bed of Geneva Lake.

Proposed Geneva Lake project includes the dredging of 321 cu yd of lakebed and built-up sediment by then removing and relocating dredged materials to an approved off-site disposal site. Steep gradients and various streams surrounding this section of the lake have deposited excess sediment that has impacted a dry hydrant intake and decreased water depth.

The Department will review the proposal provided by the applicant and any information from public comments and the public informational hearing. The Department will determine whether the proposal complies with ss. 1.11, 30.20 and 30.208, Stats., and ch. NR 150, Wis. Adm. Code, and ensure that the required mitigation meets the standards in s. 281.36(3r), Stats. if the project impacts wetlands.

The Department has made a tentative determination that it will issue the permit or contract for the proposed activity.
